**MAY 31, 2020 AND JUNE 30, 2020 LICENSE RENEWAL DEADLINES
AUTOMATICALLY EXTENDED, AS FOLLOWS:**

Pursuant to Board action summarized below, effective May 20, 2020, an automatic license renewal deadline extension up to and including August 31, 2020 is granted to licensees holding a current unexpired Alabama license that expires on May 31, 2020.

Failure of those whose licensing renewal deadline of May 31, 2020 has been automatically extended, to file the required licensing renewal documentation by August 31, 2020, will result in their license lapsing on September 1, 2020.

Pursuant to Board action summarized below, effective May 20, 2020, an automatic license renewal deadline extension up to and including September 30, 2020 is granted to licensees holding a current unexpired Alabama license that expires on June 30, 2020.

Failure of those whose licensing renewal deadline of June 30, 2020 has been automatically extended, to file the required licensing renewal documentation by September 30, 2020, will result in their license lapsing on October 1, 2020.

MOTION:

Pursuant to the emergency rule approved and adopted by the Board on April 15, 2020 allowing the Board, under the specific conditions outlined therein, to temporarily modify its examination requirement for licensure and given the understanding that approved testing facilities are closed nationwide due to the Covid-19 declared state of emergency, it is moved that for the public health, safety or welfare that a valid and enforceable temporary Alabama contractors' license be issued to those applicants before the Board today, who the Board finds have fully and

completely complied with all of the Board's licensing requirements, except for the examination. It was also moved that for the public's health, safety or welfare that a valid and enforceable temporary Alabama contractors' license be issued to those out of state applicants before us today, who lack reciprocity, but who are in good standing and who, except for the examination, otherwise fully comply with all our Board licensing's requirements so long as these applicants have successfully passed required exams mandated by their state contractors board for the same or equivalent license classification(s) they are seeking in Alabama. It is further moved that the Board issue this valid and enforceable temporary contractors' license subject to each contractor with this temporary license successfully completing his or her required examination on or before the expiration date identified on the contractors' temporary Alabama license.

EMERGENCY RULE:

**230-X-1-.34.01ER Authority for Issuing Temporary License(s) Pending Required
Examination(s) for Otherwise Qualified Applicants During a COVID-19 Declared State of
Emergency**

Where an applicant's good faith ability to take required examinations is adversely impacted by the ongoing closure of approved testing facilities in the county, city, parish and/or province where the applicants principal place of business and/or where the applicants qualifier(s) is currently located due to a Covid-19 government declared state of emergency, the Alabama Licensing Board for General Contractors has the authority to temporarily modify its examination requirements set forth at Administrative Code Section 230-X-1-.34, but only for either (1) those adversely affected applicants who otherwise fully and completely comply with all other Alabama Board licensing requirements or (2) for those adversely affected out of state applicants in good standing, who lack reciprocity, but otherwise fully and completely comply with all Alabama Board licensing requirements and who have successfully passed required exams mandated by their state contractors board for the same or equivalent license classification(s) they are seeking in Alabama. Under these limited conditions a valid and enforceable temporary

contractors' license will be issued subject to the required examination being successfully completed on or before the expiration date identified on the contractors' temporary license.

Moreover, where an applicant's demonstrated good faith efforts to take required examinations continues to be impeded by the above-referenced ongoing closure of approved testing facilities due to a Covid-19 government declared state of emergency, the Chairman of the Board may on a case by case basis authorize the Board's Executive Director to extend the contractor's temporary active license for up to an additional 90 days subject to the Board Chairman's final approval.

This rule does not eliminate the Board's required examination prerequisite for licensure and does not expand or modify the license in issue. The adoption of this rule is deemed necessary for the public's health, safety or welfare.

MARCH 25, 2020 NOTICE OF BOARD ACTION

THE MARCH 31, 2020 LICENSE RENEWAL DEADLINE IS AUTOMATICALLY EXTENDED AS FOLLOWS:

Pursuant to Board action summarized below, effective March 25, 2020, an automatic extension up to and including June 30, 2020 is granted to either licensees holding a current unexpired Alabama license or to those licenses holding a current Alabama license extension that expires on March 31, 2020.

Failure of those whose licensing renewal deadline of March 31, 2020 has been automatically extended, to file the required licensing renewal documentation by June 30, 2020, will result in their license lapsing on July 1, 2020.

Summary of Board Action Taken on March 25, 2020:

On March 25, 2020, and pursuant to Governor Ivey's March 2020 proclamations, the State of Alabama Licensing Board for General Contractors held a specially called meeting needed to respond to COVID-19 by adopting the following emergency rule deemed necessary for the public's health, safety and welfare, which provides the Board the authority to extend the Board's licensing renewal procedures deadlines set forth at Administrative Code Section 230-X-1-.01 during a Governor declared state of emergency. This emergency rule was adopted at this March 25, 2020 specially called Board meeting that convened at 10:04am and adjourned at 10:18am and is available for review below:

EMERGENCY RULE:

230-X-1-.01ER Authority for Extending License Renewal Filing Deadlines During a Declared State of Emergency

Where a state of emergency has been declared by the Governor of the State of Alabama, the Alabama Licensing Board for General Contractors has the authority to modify its licensing renewal filing deadline procedures set forth under its Administrative Code Section 230-X-1-.01 for those holding a current unexpired Alabama license or for those holding a current Alabama license extension when said emergency declaration impedes a prime contractor and/or subcontractor's good faith ability to timely comply with the Board's licensing renewal deadline procedures for his or her current Alabama license as set forth under the Board's Administrative Code Section 230-X-1-.01. Moreover, when the declared state of emergency adversely impacts the ability to meet the Board's aforesaid licensing renewal filing deadlines as stated, the Chairman of the Board may authorize the Board's Executive Director to modify the Board's aforementioned licensing renewal filing deadlines for those holding a current unexpired

Alabama license or those holding a current Alabama license extension, subject to the Board Chairman's final approval before said limited modifications go into effect. This rule does not expand or modify the license in issue and the adoption of this rule is deemed necessary for the public's health, safety or welfare.

MOTION:

A motion was made that for the public health, safety or welfare the March 31, 2020 licensing renewal deadline be automatically extended for 90 days and up through June 30, 2020 for those prime contractors and subcontractors holding a current unexpired Alabama license or those holding a current Alabama license extension to allow them up through June 30, 2020 to file the required license renewal documentation with the Board's office. Failure of those whose renewal deadline of March 31, 2020 has been automatically extended to file the required renewal documentation by June 30, 2020, will result in their license lapsing on July 1, 2020.
